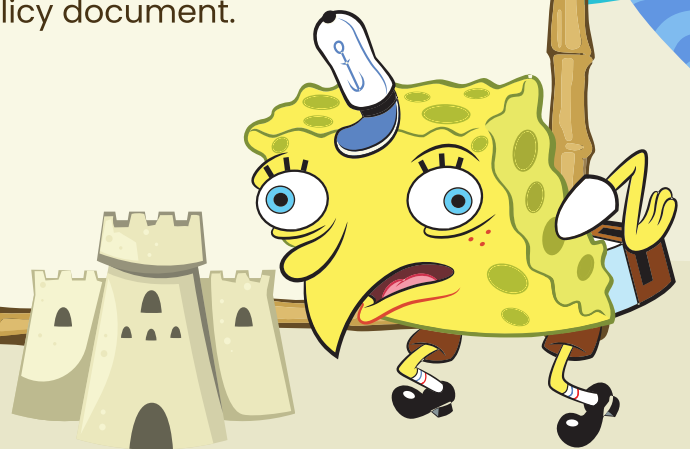
1. Information We Collect

2.2 Communication: We may use your email address to send important updates, announcements, and information related to the SpongeV2 token.

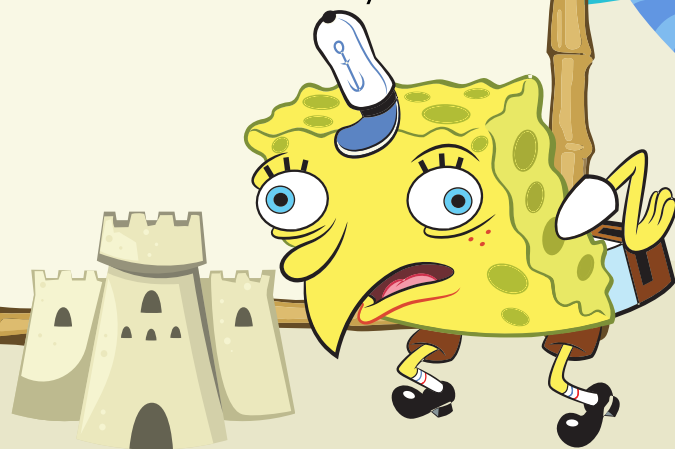
2.3 Improving Services: We use collected data to analyze usage patterns and improve the functionality and performance of sponge.vip and the SpongeV2 token.
