TERMS OF USE

These Terms of Use ("Terms") govern your use of the sponge.vip website, related services, and any associated software (collectively, the "Service"). 1. The SPONGEV2 Token

The \$SPONGE and \$SPONGEV2 Tokens are digital crypto tokens developed on the Ethereum blockchain by the SBSP LTD, who is registered in Panama and has the offices in Espana Delta Bank Building 6th Floor, Panama City, Panama.

2. Eligibility

5.2.2. Risks: Staking involves certain risks, including the potential loss of staked tokens. Users should carefully consider these risks before participating in staking.
